Dear Board Members:

Enclosed please find a CFA-4 form with Addendum and one CFA-11 form with Addendum. These two forms are identical in all respects to those originally submitted by the Kelty for Mayor Campaign on January 17, 2007 and April 25, 2007, respectively. Also enclosed is a CFA-11 form dated May 24, 2007 which reports a contribution received by the Kelty for Mayor Campaign on May 4, 2007 which was, through inadvertence, not previously reported.

The addenda clarify the sources of the personal funds I used to make loans of \$140,000.00, \$8,000.00 and \$8,000.00 that were previously reported and the loan of \$2,000.00 that is reported in the CFA-11 form filed today to the Kelty for Mayor Campaign Committee. Since the filing of the previous forms, I have become aware of a possible, but unclear, requirement to report the source of the funds used by a donor to make a campaign contribution or loan. While counsel and I have concluded that such information need not be provided generally or in this specific situation, I have decided to file these addenda in the interest of the absolute transparency of my campaign and the strength of my integrity.
